The CPAD is a proprietary database owned by GreenInfo Network, a non-profit California corporation. Subject to your compliance with the terms of this Agreement, GreenInfo Network grants to you a personal, nonexclusive, nontransferable and royalty-free right to use the database solely for the purposes set forth below.
