CPAD v. 1.7 Release Notice

An update to the California Protected Areas Database (CPAD) has just been published by GreenInfo Network (www.GreenInfo.org). CPAD is the only comprehensive, high-resolution, statewide GIS data showing all of California's protected areas, from the smallest urban parks to the largest national park and wilderness areas.

A total of 49,152,000 acres of protected open land are now inventoried in CPAD (just under half of California's total land area) – this total is made up of 53,400 separate holdings or parcels, that are grouped into just over 15,000 units (e.g., a specific named park or preserve), and are owned by 940 governmental agencies, and non-profit and other organizations. CPAD only contains data about lands protected for <u>open space purposes</u> and owned <u>in fee</u> by agencies and organizations. A separate Easement Edition of CPAD will be released in late-2011, containing GIS data on selected easements in the state.

What's New

This version of CPAD continues to refine the database with better parcel alignment, removal of inferior legacy data, and addition of newly protected areas. CPAD 1.7 includes 24 more agencies/organizations than CPAD 1.6, including a net increase of over 65,000 acres of protected areas. It has roughly 550 more Holdings and 180 more Units than version 1.6.

USES OF CPAD: The protected areas data is suitable for general planning and analysis by government agencies, non-profits, private businesses, planning consultants and many other users, including individuals with access to GIS technology. The public web site **www.ParkInfo.org** allows any user with Internet access to find and view interactive maps of publicly accessible protected areas.

NOT OFFICIAL OWNERSHIP DATA: CPAD data is not a replacement for and does not override official land ownership data for any individual agency – users needing the most up to date, or official boundaries must contact relevant agencies for that information. CPAD data may not be fully up to date or accurate in relation to owning agency data and is provided "as-is" to users.

NATIONAL PROGRAM: CPAD is also an element in a national program to improve protected land inventories – learn more about the Protected Areas Database of the United States (PAD-US, of which CPAD is a part) at the US Geological Survey's Gap Analysis Program web site (http://gapanalysis.usgs.gov).

FUNDING AND FUTURE UPDATES: CPAD is updated as funding becomes available – there is currently no dedicated source of ongoing support for CPAD, so additions and corrections are limited to funding opportunities.
